


John & Genie cooked BBQ hamburgers, made salads and supplied desserts & drinks for the meeting. Very gracious hosts.



Cameo - Chevrolet's Other Glass Vehicle

My favorite automobile era is the 50's. This post-war period saw revolutions and revelations in design, style and class that make these cars a favorite for many even after 50 years. Most people of any age just have to smile when they see one of these cars. For me, they bring back teen years, which were a lot different than teen years of today.

The Corvette was born in '53, with unique features such as the fiberglass body that endure yet today and make this car an unquestionable icon.

But our primary topic is the '55 Chevrolet pickup Series 2 that set standards and trends that also endure today. It was the first of the "fancy" trucks; designed to appeal to other than farmers wanting to haul hay & livestock and meander around in their fields.

Chevrolet made two completely different trucks in 1955. The Series 1 continued the pre-war style of truck, with the flat windshield with center post, rounded fenders, and a basic body style that dated well back into the '40's. The Series 2 evidently excited Chevrolet so much that they could not wait for the '56 model year, and offered it as a '55 as well. This truck had the wraparound windshield, V8 265 cubic inch engine option, and a knockout "egg crate" grill, among many other features that made it a run-away trend setter for several ensuing years.



They also made a "fancy" version of this truck, Chevrolet's "other glass vehicle" that had fiberglass rear fender shells faired neatly into the body, a fiberglass tailgate cover,

and a fiberglass spare tire carrier under the bed, accessible through a hinged section of the rear bumper. It also had lots of chrome and options. You had a "choice" of colors of Bombay Ivory with a red box and trim. (Just like Ford's "choice" of Black.) They called it the Cameo.

In my opinion, this is the classiest, cleanest pickup truck that has ever been made to date. It just oozes charm.

I bought one in 1960 as a teenager, and still have that truck today, undergoing "rodding and restoration" that will retain the classic looks of the Cameo but will be completely modern inside and out. More about that in a future article. But my "original" Cameo has some issues. It was stored for 35 years and was messed up in several ways.

Recently, while surfing the web to solve some of these issues. I came across an original, but not heavily optioned Cameo that was neat, clean and mostly intact. Two days later I drove to Portland with my Haulmark car trailer and picked it up. I am now the proud owner of 2 '50's Chevy Trucks, for



better or worse! This one has the 235 six, and does not have the "heater" option.

Taking it for a hop around the neighborhood drew quite a crowd. Even had some follow me home to talk about it. I used many of its Cameo parts on the rod, converting this 2nd Cameo into a "standard" model, using many parts that I already owned. I have acquired a 327 Corvette engine and a PowerGlide transmission to put it this 2nd truck. With a power steering conversion kit and the heater from my original, which now has a full air conditioning conversion, it will be my "driver".

I plan on bringing it up to "more than tidy" with a little detailing, new bed wood, refinishing the engine compartment and taking it to a few of the Saturday drive-in sessions around the area.

The "Smiles per mile" factor on these trucks is astronomical!

One of the nicest things about these trucks is that even after 50 years they are so popular that you can buy almost any part you need, right down to a glove box latch. Also, I can work on it without connecting a diagnostics plug. Yay!

"Tour" Radios Available Through CMCS



The "business" UHF radios that the Club uses to coordinate tours are now available for purchase from CMCS.

Our settings are:

Frequency: 467.9000 Mhz

Interference Frequency 179.9 Hz.

These are UHF frequency radios.

Note: "Family" VHF radios will not work!

You may purchase a radio at CMCS General Meetings or by contacting the CMCS Vice-President Wayne Kanaby.

Be sure and acquire your radio before you intend to use it, to allow time for battery charging and programming.

NOTE: These are commercial/professional quality units, not toys.

Battery Replacement for the Motorola Spirit Series Radios

Many of "older" members (those that have been in the club for 10 years or more) have the Motorola Spirit series of radios. Ours are the MU22 model. They came with a custom Ni-Cad battery pack with a life of about 5 years or so. The radios work great and are very rugged and long-lasting. Tech Wholesale (www.techwholesale.com) now offers a newer NI-MH battery pack for these radios for a little over \$26 total to you. Part Number is NH9044. You can say goodbye to the Ni-Cad and keep your radio for many more years!
